## SCHOLARSHIP OPPORTUNITIES

### ♦ CHILD/GRANDCHILD -

- o The child or grandchild of a TREA member. The sponsor (the parent or grandparent) must be a current member, or if passed, was a current member at time of passing.
- o Scholarships are awarded based on various criteria, make sure that you check the correct scholarship type that you are applying for. The options are:
  1. Academic – based on current GPA, community service, extra-curricular activities and overall academic achievements.
  2. Financial – this scholarship uses the same criteria as the academic scholarship, but additional consideration is given for students/families with financial stress/needs. Documentation and proof of financial need will be required. Please call TREA Headquarters for more details.
  3. Special – this scholarship takes into account students who may have a learning disability or delay. Documentation is required to support this scholarship, such as a current IEP, 504 Plan or written documentation from the school.
- o Most scholarships are awarded for full-time undergraduate study at an accredited school, however, scholarship opportunities are available for vocational and technical schools & programs. It is important that you check the correct box.

### ♦ TREA MEMBER/SPOUSE –

- o This program is specifically for you, the TREA member and/or your spouse and is designed to help you obtain the necessary education/skill needed to enhance/build your professional/career resume, or to assist you in a career change.
- o There is a specific application (different than the one for 'child/grandchild').
